My name is Tim Stokes and I am a sheep and beef farmer in the Waipuna catchment. My family and I have been farming this country for over 100 years.

## Comments on the proposed plan change document:

Once the changes I highlight in the following pages find their way into the Plan Change 1 it will be the same way that the rest of tourism does not fit in too.

In relation to the High nitrogen referencing point, every property would be different under different management so it is unfair to put a reference point for a property based on a point in the past.

It would be much easier to have individual plans and to have them designed based on the merits of each individual property for each property.

As a sheep and beef farmer the regulations proposed on page 341 do not seem to be applying to me.

The restrictions related to what can be done on stock would cause many to not be able to continue running cattle here.

Many of the proposed restrictions could be relaxed with more confidence and less chance. For example no grazing during dry periods can be implemented for grazing methods and the type of management of the dry areas. It has been discovered by many that stock that have access to clean, recalculated water will eat, rather than waste the water by drinking ridiculous amounts which wastes water. While the need for better water becomes evident, the changes proposed will still affect the water resources.


